ABOUT THE PROJECT

Vista Ridge is a premium golf-oriented residential development by Emaar Properties within **Emaar South**, Dubai South. Set alongside the master community's championship golf course, the project combines contemporary residences with expansive fairway views, landscaped surroundings and a quieter residential environment. Emaar describes Vista Ridge as balancing understated luxury with a world-class golfing lifestyle.

The development offers **1, 2 and 3-bedroom apartments alongside a limited collection of 3-bedroom townhouses**. This gives Vista Ridge a diverse residential mix, ranging from compact homes suitable for individual buyers and investors to larger family residences with significantly more indoor and outdoor space.

Published layouts start at approximately **788 sq. ft.** One-bedroom residences are available around 793 sq. ft., two-bedroom apartments around 1,384 sq. ft. and three-bedroom apartments around 1,748 sq. ft. The larger three-bedroom townhouses extend to approximately **2,763 sq. ft.**, representing the upper end of the project's residential offering.

Vista Ridge's architectural concept is strongly influenced by its golf-course setting. Emaar uses contemporary lines and expansive glazing to frame the surrounding landscape, while interiors incorporate **textured stone, warm timber, soft neutral tones, earthy browns and muted greens**. This creates a restrained interior palette designed to complement the surrounding fairways rather than compete with

them.

The amenity programme includes an **adult swimming pool, children's pool, splash pad, children's play area, padel court, event lawn, barbecue area, ping-pong facilities, indoor and outdoor yoga spaces, indoor and outdoor gyms and a multipurpose room.**

Residents also benefit from the wider infrastructure of **Emaar South**, which is planned with approximately **22,700 residential units, 15,360 apartments, 53,000 sq. m. of retail and dining space, 25 neighbourhood parks and an 18-hole championship golf course.**

The community's Dubai South location places Vista Ridge close to **Al Maktoum International Airport and Expo City Dubai**. Emaar highlights this connectivity as an important part of Emaar South's long-term proposition, particularly as infrastructure and economic activity continue expanding across the Dubai South corridor.

Vista Ridge is scheduled for completion in **Q3 2029**, with current project records specifying **30 September 2029**. The payment structure is **80/20**, consisting of **10% at booking, 70% during construction and 20% upon handover.**

From an investment perspective, Vista Ridge combines **Emaar branding, direct golf-course positioning and exposure to Dubai South's long-term growth.** However, Emaar South has an expanding pipeline of golf-oriented residential projects. Buyers should therefore compare Vista Ridge carefully against Golf Hills, Golf Hills 2, Golf Meadow, Golf Vale and Grove Ridge rather than relying solely on the master-community location.

Individual unit selection is especially important. **Golf-course orientation, floor, unobstructed views, layout efficiency, balcony size and acquisition price per square foot** can create meaningful differences in future rental and resale positioning.
